INTERIM DETERMINATION ON EX- FACTORY GRADE 300 AND GRADE 500 REBAR PRICE

DATE: 18 MARCH 2011

Following the interim determination on wholesale rebar price of Grade 300 and 500 (unchanged) on 25 February 2011, Fletcher Pacific Steel (FPS), a Division of Fletcher Building Limited, requested for a review in their rebar price on 3 March 2011, based on the following:

- Increase in raw material price due to scrap price movement and;
- Devaluation of Fijian dollar against New Zealand Dollars

The Commission, after a careful analysis of the submission by FPS, has authorised an interim increase of 9.5% on wholesale rebar price for Grade 300 and 500. As part of the interim increase the Commission has taken into account the 5% increase in electricity tariff which will come in effect from 1 April 2011 and also the strengthening of Fijian dollar against the New Zealand Dollar.

The authorised prices by the Fiji Commerce Commission are to be effectively from 21 March 2011 and as follows:-

This is an interim Determination while the Commission is currently investigating:-

- 1. Conversion cost
- 2. Purchase price of billets on competitive basis

Please note that the above prices will expire on 31 May 2011. On 1 June 2011, the Commission will release the final determination on wholesale rebar prices for Grade 300 & Grade 500.
