1.0 Introduction

- 1.1 On 24 March 2010, Section 3 of the Commerce Act 1998 was amended through the Commerce Act (Amendment) Decree 2010 (now referred as the Commerce Commission Decree 2010) which authorized the Commission to regulate the Marina Operators in Fiji. Subsequently the Commerce (Control of Prices for Ports and Marina Management Services) Order 2010 was issued which empowers the Fiji Commerce Commission ("Commission") to control and/or regulate the Ports and Marina Management Services in Fiji.
- 1.2 This effectively means that the Commission is empowered under the Order and the Commerce Commission Decree 2010 ("CCD2010") to call for submissions from the stakeholders and fix and declare maximum authorised fees and charges for ports and marina management services. The Order subjects all ports and marina management services to Price Control and Determination by the Commission.
- 1.3 On 16 May 2014, the Commission released the final authorization for the introduction of fees and charges for Royal Suva Yacht Club ("RSYC") for mooring, haul-out fees, rescue boat hire and other fees and charges at the facility effective from 16 May 2014.
- 1.4 On 8 December 2014, the Commission received a formal submission from RSYC requesting for a review of marina fees and charges.
- 1.5 On 9 December 2014, the Commission requested for additional information in order to ascertain the proposed increase in fees and charges.
- 1.6 On 10 December 2014, a meeting was held at the Commission for discussion on RSYC submission and the additional requirement by the Commission.
- 1.7 On 17 December 2014, the Commission via an email requested for additional information/clarification from RYSC.
- 1.8 Final submission was received from RYSC on 18 December, 2014.
- 1.9 Based on the submission made by RSYC and the Commission's independent assessment, the Commission has made this authorisation.

2.0 Legal Framework

- 2.1 The Commission is empowered under the ***Commerce (Control of Prices for Ports and Marina Management Services) Order 2010*** to control and/or regulate the ports and marina management services in Fiji.
- 2.2 Paragraph 3 of the said Order specifically authorises the control and/or regulation of prices or rates for the supply of all ports and marina management services in Fiji.
- "ports and marina management services" means all services and facilities provided by a port and its marina including but not limited to the following:*

- (a) Services including but not limited to berthing, barge and towing and sea transportation services; and
- (b) Facilities including but not limited to shops, office facilities, car parks and terminals located at the marina premises.

2.3 The Commerce (Control of Prices for Ports and Marina Management Services) Order 2010 authorises the Commission to regulate and control prices for five (5) years which expires on 24 March 2015.

3.0 Commission's Authorisation

Based on the submission made and through the Commission's independent research, study, and analysis, the Commission authorizes the following fees and charges for Royal Suva Yacht Club:
