 Pursuant to Section 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for the Supply of Cement Products) Order 2018, the FCCC hereby makes the following authorisation.

#### Citation and commencement

2. This Authorisation may be cited as Final Authorisation for Wholesale Price of Bagged and Bulk Cement for Pacific Cement Limited and is effective from 1 October 2019.

#### Maximum Prices

- 3. (a) The prices set out in Schedule 1 herein shall be the maximum ex-factory wholesale prices applicable at which the goods and services mentioned therein may be supplied as listed in Schedule 1 by Pacific Cement Limited.
  - (b) No new charges shall be levied unless authorised by the FCCC.
