The Fijian Competition & Consumer Commission (FCCC) is an independent statutory body established under Section 7 of the FCCC Act 2010 that promotes effective competition and informed markets, encourages fair trading, protects consumers and businesses from restrictive practices, controls prices of regulated industries and other markets where competition is lessened or limited.

### **Purpose of the Role**

The incumbent will be required to carry out day to day monitoring, inspection, market surveillance, investigation and complains handling activities with the FCCC Price Control & Monitoring team. The incumbent will be also required to assist in other relevant duties in the regional division as and when assigned.

#### Nature & Scope

The Assistant Monitoring Officer works closely with the Monitoring Officer and Regional Managers for the conduct of all price control and monitoring activities that are part of the Strategic Goals of FCCC. Development of relevant capacities required for this role is both an individual and organizational obligation to ensure the officer attains the level of competency expected for the position.

Assist the Monitoring Officer and Regional Manager West to coordinate & conduct price inspection by visiting various trader premises to ensure they comply with the requirements of FCCC Act 2010.

- Update the inspection work and protocols used for inspecting the Traders.
- Informed about latest developments within particular sectors e.g. retail, wholesale and master price lists.
- Assist the team to carry out price inspections for all the trader shops, including urban, rural and outer islands areas as well.
- Assist in Educating and assisting traders on FCCC Act 2010 to compliance requirements and matters relating to pricing for control items and requirements for price control and non price control items.
- Assist in Investigating consumer complaints to determine if there has been a breach of FCCC Act 2010;
- Ensure accuracy in providing and collecting prosecution evidences. Assist in conducting caution interviews for traders warned for prosecution.
- Assist in preparing legal files for non-compliance traders.
- Assist in court cases if a decision is made to prosecute and also appear as a witness for FCC in court.
- Assist in conducting and lead market surveys for any assigned tasks and provide a report.
- Updating relevant templates for records of breaches, inspections spot fined traders and any other assigned tasks.
- Assist in ensuring quality and accuracy in presentation during awareness to stakeholders and consumers.
- Participate in Provincial Council Meetings, Tikina Council Meetings and Advisory council meetings.
- Prepare and submit reports and periodic reports as required and assist in ensuring that the relevant departmental targets are completed on time in accordance with established procedure.
- Ensure all Occupational Health & Safety procedures are followed according to the Health and Safety At Work Act 1996 while carrying out hazardous work outside or within the Office Premises.
- Ensure all the hazards concerning the area of work are highlighted prior to the Department Manager.
- Ensure Innovation and continuous improvement and business excellence strategies are implemented on a random basis to achieve the desired outcome of FCCC.
- Carry out any other duties as and when required and in line with the FCCC Act 2010.
