Final Authorisation on Grade 300 and Grade 500 Reinforcement Steel Rods Prices for BlueScope Pacific Steel (Fiji) Pty Pte Limited

1. Pursuant to sections 39 and 41(1A) of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for Reinforcement Steel Rods) Order 2018, Fijian Competition and Consumer Commission (FCCC) hereby makes the following authorisation.

Citation and Commencement

- 2. This Authorisation may be cited as Final Authorisation on Grade 300 and Grade 500 Reinforcement Steel Rods Price for BlueScope Pacific Steel (Fiji) Pty Pte Limited (Authorisation).
- 3. This Authorization is effective from 21 October 2021.

Maximum Authorised Prices

4. The prices set out below shall be the maximum authorised prices for the below specified types of reinforcement steel rods:

Maximum Authorised Ex-Factory Prices for Reinforcement Steel Rods

Re-Bar Grade	Types	Maximum Authorised Price (VEP) per Tonne FJD
Grade 300	Plain/Deformed	\$2,129.36
Grade 500	Plain/Deformed	\$2,203.84

For the purposes of this Authorization, ex-factory price means the maximum authorized price BlueScope Pacific Steel (Fiji) Pty Pte Limited can charge to customers from steel rolling mill situated at Leonidas Street, Walubay, Suva, Fiji.

Conditions of this Authorisation

5. Bluescope Pacific Steel (Fiji) Pty Pte Limited shall provide the landed cost of billet to FCCC every month from the effective date of this Authorisation.

Validity

6. This Authorisation supersedes all previous authorisations, agreements or understandings in connection with its subject matter.


- **7.** This Authorisation shall remain valid until 13 November 2021 unless this Authorisation is varied, extended or revoked.
- **8.** No new price pertaining to the supply of reinforcement steel rod products in all quantities and classes in Fiji shall be levied, applied or charged unless authorised by FCCC.
