# Final Authorisation on Tug Service Charges and Commissions for Fiji Ports Corporation Limited

Pursuant to section 39 and section 41 of the Fijian Competition and Consumer Commission (FCCC) Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for Ports Management Services) Order 2021, FCCC hereby makes the following authorisation.

#### Citation and commencement

1. This Authorisation is cited as Final Authorisation on Tug Services Charges and Commissions for Fiji Ports Corporation Limited and is effective from 18 March 2022.

#### **Maximum Prices**

2. The prices set out in the Schedule are the maximum charges applicable, as the case may be, at which the services mentioned therein may be supplied.

#### **Maximum Commission**

3. The maximum commission that may be charged for tug services is 25%.

#### Validity

4. This Authorisation supersedes all previous authorisations, agreements or understandings in connection with its subject matter.

#### **Expiration of Authorisation**

5. This Authorisation expires at the start of 28 March 2024, unless earlier revoked, amended, or varied by FCCC.

#### New prices must be authorised

No new price pertaining to the supply of Tug Services in Fiji are to be levied, applied or charged unless authorised by the Fijian Competition and Consumer Commission.
