## **Interim Authorisation of Fares and Charges for Minibus Services in Fiji**

Pursuant to sections 39 and 41 of the Fijian Competition and Consumer Commission Act 2010 and the **Fijian Competition and Consumer Commission (Control of Fares and Charges for Public Service Vehicles) Order 2020**, the Fijian Competition & Consumer Commission (**Commission**) hereby makes this Authorisation.

### ***Citation and commencement***

1. This Authorisation may be cited as the Interim Authorisation for Fares and Charges for Minibus Services in Fiji and is effective from **8 August 2022**.

### ***Fares for Minibus Services***

2. The fares set out in Schedule 1 are the maximum fares at which minibus services may be charged in the areas specified in the Schedule.

### ***Fares for Carrier Services***

3. The carrier fares fixed by the Land Transport Authority pursuant to the Land Transport Act 1998 prior to 1 February 2020 are deemed to have been authorised under this Authorisation.

### ***Conditions to this Authorisation***

4. No new fares or charges shall be applied, charged, or levied unless authorised by the Commission.

### ***Expiry of this Authorisation***



5. This Authorisation shall remain in force until **31 March 2023** unless earlier revoked, amended, or varied by the Commission.

### ***Revocation***

6. The Final Authorisation for Fares and Charges for Minibus Services in Fiji issued on 20 July 2022 (effective from 20 July 2022) is revoked.
