**Interim Authorisation for Air Navigation Service Charge for Airports Fiji PTE  
Limited**

1. Pursuant to Section 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for Aeronautical Services) Order 2019, the FCCC hereby makes the following authorisation.

***Citation and commencement***

2. This Authorisation may be cited as Interim Authorisation for Air Navigation Service Charges for Airports Fiji PTE Limited and is effective from **1 January 2022**.

***Maximum Prices***

3. (a) The prices set out in Schedule 1 herein shall be the maximum authorized enroute service unit fee applicable for the services mentioned therein Schedule 1 by Airports Fiji PTE Limited.

(b) No new charges shall be levied unless authorised by the FCCC.




6. No new price pertaining to the Air Navigation Services in Fiji by Airports Fiji PTE Limited shall be levied, applied or charged unless authorised by the Fijian Competition and Consumer Commission.
