Authorisation of Prices for the Supply of Wheat Products Ex-factory in Fiji

 Pursuant to section 41 of the Fijian Competition and Consumer Commission Act 2010 (FCCC Act 2010) and the Fijian Competition and Consumer Commission (Wheat Products) (Ex-factory, Wholesale and Retail) Order 2022, the Commission hereby makes the following Authorisation:

Citation and commencement

2. This Authorisation may be cited as Authorisation of Prices for the Supply of Wheat Exfactory Products in Fiji and is effective from **08 December 2023**.

Maximum prices

- **3.** (a) The prices set out in Part 1 of the Schedule are the maximum prices at which the goods mentioned in that Part may be sold and delivered ex-factory.
 - (b) Where the maximum price of an item listed in Part 1 of the schedule is required to be rounded up to the nearest whole number by reason of the cessation of the 1 cent and 2 cents denominations, the consequential increase in the price of that does not constitute a contravention of this Authorisation.
 - (c) Ex-factory prices apply from the factory and a reasonable delivery cost may be charged and to be shown separately.

Value Added Tax (VAT)

- **4.** Manufacturers must state Value Added Tax (VAT) separately in the invoice provided at the time of sale.
- 5. No new charges shall be applied unless authorised by the Fijian Competition and Consumer Commission.
- **6.** This Authorisation is approved by the Fijian Competition and Consumer Commission Board effective from **08 December 2023.**
- 7. The Maximum authorised Ex-factory Wholesale prices are as follows:
