Final Authorisation on Marina Fees and Charges for Waitui Marina

1. Pursuant to Section 39 and 41 of the Fijian Competition and Consumer Act 2010 and the **Fijian Competition and Consumer Commission (Control of Prices for Marina Management Services for Passengers on Commercial Ships and Cargo Transportation) Order 2024**, FCCC makes the following authorisation on the marina fees and charges for Waitui Marina.

Citation and commencement

2. This Authorisation may be cited as Authorisation for Marina Fees and Charges by Waitui Marina and is deemed to have come into force on **29 March 2024**.

Maximum prices

3. (a) The prices set out in Schedule 1 herein shall be the maximum rates applicable, as the case maybe, at which the goods and services mentioned therein may be supplied as listed in Schedule 1.
- (b) No new charges shall be levied, applied or charged unless authorised in writing by the Fijian Competition & Consumer Commission (**FCCC**).
