## Final Authorisation on Marina Fees and Charges for Copra Shed Marina

- Pursuant to Sections 39 and 41 of the Fijian Competition and Consumer Commission Act 2010 and the **Fijian Competition and Consumer Commission (Control of Prices for Marina Management Services for Passengers on Commercial Ships and Cargo Transportation) Order 2024**, FCCC makes the following Authorisation on the marina fees and charges for Copra Shed Marina.

### *Citation and commencement*

- This Authorisation may be cited as Final Authorisation for Marina Fees and Charges by Copra Shed Marina and is deemed to have come into force on **29 March 2024**.

### *Maximum prices*

- The prices set out in Schedule 1 herein shall be the maximum rates applicable, as the case maybe, at which the goods and services mentioned therein may be supplied as listed in Schedule 1.
  - No new charges shall be levied, applied or charged unless authorised in writing by the Fijian Competition & Consumer Commission (**FCCC**).
