**Interim Authorisation for Wholesale Price of Bagged and Bulk Cement for Pacific  
Cement Pte Limited**

1. Pursuant to Section 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for the Supply of Cement Products) Order 2021, the FCCC hereby makes the following authorisation.

***Citation and commencement***

2. This Authorisation may be cited as Interim Authorisation for Wholesale Price of Bagged and Bulk Cement for Pacific Cement Pte Limited and is effective from **20 May 2024**.

***Maximum Prices***

3. (a) The prices set out in Schedule 1 herein shall be the maximum ex-factory wholesale prices applicable at which the goods and services mentioned therein may be supplied as listed in Schedule 1 by Pacific Cement Pte Limited.

(b) No new charges shall be levied unless authorised by the FCCC.

**Schedule 1: Pacific Cement Pte Limited Wholesale Cement Prices**

***Conditions of this Authorisation***

4. Pacific Cement Pte Limited is required to provide the cost details of all imported raw materials to FCCC every 20th day of the month from the effective date of this Authorisation.

***Validity***

5. This Interim Authorisation supersedes all previous authorisations, agreements, or understandings in connection with the Supply of Cement Products in Fiji by Pacific Cement Pte Limited.
6. This Interim Authorisation shall remain valid until the Authorisation is varied, extended or revoked by the Fijian Competition & Consumer Commission.
7. No new price pertaining to the supply of Cement products in Fiji by Pacific Cement Pte



Limited shall be levied, applied or charged unless authorised by the Fijian Competition and Consumer Commission.
