## Final Authorisation for Postal Tariff for Domestic Services for Post Fiji PTE Limited

1.0 Pursuant to sections 39 and 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for Postal Services) Order 2024, FCCC hereby makes the following authorisation.

### *Citation and commencement*

2.0 This authorisation may be cited as Final Authorisation for Postal Tariff for Domestic Services for Post Fiji Pte Limited (**Authorisation**).

3.0 This Authorisation shall be deemed to be effective from 15 September 2024.

### *Maximum Prices*

4.0 The prices set out below shall be the maximum authorised price for the following domestic services in Fiji:

6.0. This Authorisation shall remain valid 15 September 2027 or until this Authorisation is earlier revised, varied or revoked.


