Final Authorisation of Fares and Charges for Omnibus Services in Fiji

Pursuant to sections 39 and 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Fares and Charges for Public Service Vehicles) Order 2023, the Commission hereby makes this Authorisation.

Citation and commencement

1. This Authorisation may be cited as the Final Authorisation for Fares and Charges for Omnibus Services in Fiji 2025 and is effective from **1 August 2025**.

Fares for Omnibus Services

- 2. (a) The fares set out in Schedules 1, 2, and 3 are the maximum fares applicable at which omnibus services may be charged in the areas specified in the Schedules.
 - (b) For Express and Long-Haul trips, an additional \$0.20 will apply for each applicable stage by omnibuses operating direct services between major towns and cities with limited stops or no stopping in between, as stipulated in the respective Road Route Licences.

Conditions to this Authorisation

3. No new fares or charges shall be applied, levied or charged unless authorised in writing by the Fijian Competition and Consumer Commission.

Expiry of this Authorisation

4. This Authorisation expires on **31 January 2026** unless the Authorisation is varied, extended or revoked by the Fijian Competition and Consumer Commission.

Revocation

5. The Final Authorisation for Fares and Charges for Omnibus Services in Fiji issued on 28 August 2024 (effective from 1 September 2024) is revoked.
